BANQUET BAR MENU

Choose between three different bar tiers: Ruby, Sapphire or Diamond. All bar tiers include Liquor, Wine, Beer, Juices, standard mixers, and premium mixers. All service of alcohol purchased at Downstream Casino Resort must be provided by Downstream Casino Resort personnel. No outside alcohol is permitted in banquet event space or in hotel rooms being utilized in a banquet event capacity.

A 23.5% Service Charge will be assessed for all hosted and cash bar purchases, including drink tickets and pre-purchased alcohol. Alcoholic Beverages are Subject to a 13.5% State Alcohol Tax & an 11% Quapaw Tribal Alcohol Tax.

STANDARD BAR FEES

A bartender fee of \$150 will reserve one private bartender for a 4-hour block. After the 4-hour block, an additional \$25 per hour, per bartender will be added to the banquet check.

One bartender is required per every 100 guests.

SPECIALTY COCKTAILS & PREMIUM MIXERS

Each bar tier comes equipped with premium mixers. Premium mixers to include; Coconut Rum, Peach Liqueur, Melon Liqueur, Raspberry Liqueur, Amaretto, Blue Curacao and Triple Sec.

All Premium Mixers contain alcohol and will be a \$3 upcharge per mixer ordered.
